A. with its registered office in Warsaw, Czerska 8/10 Street, 00-732 Warsaw (provider of the Service and controller of Users' personal data), entered into: the National Court Register maintained by the District Court for the Capital City of Warsaw, 13th Commercial Division, register of entrepreneurs, number 59944, Tax Identification Number: 526-030-56-44, share capital 46.580.831,00 PLN, fully paid up, corporate service address: www.agora.pl, e-mail: pomoc@wyborcza.pl
